Assistance may be available to those individuals/organisations that have not previously visited the Isle of Man as part of a familiarisation visit and are directly involved in the development of the programme.

Section C – Measuring the success of the Familiarisation visit

• Participants are required to submit a report, complete questionnaire, sign-up to newsletter, and undergo 'Become an IOM Expert' training.

Guidance Notes

- Individual/Organisation must not have previously visited the Isle of Man as part of a familiarisation visit
- Maximum of 2 adults per familiarisation visit
- Maximum of 3 nights' accommodation on a bed and breakfast basis at an agreed property
- Familiarisation visit to take place between January, February, March, April, or October & November, December.
- An outline schedule of visit agreed in principle with Isle of Man Tourism in advance

Detailed report to be submitted to Isle of Man Tourism no more than 4 weeks after the visit has taken place

- Individual must be directly involved with the organisation of proposed Isle of Man Tour
- Clear objectives and expected outcomes to be set in advance of visit

Who is eligible?

- Individual Group Travel Organisers planning first tour to the Isle of Man
- Group Travel Wholesalers refreshing itinerary or expand product offering or planning first tour to the Isle of Man
- Tour Operators developing tours to the Isle of Man or expanding their product offering
- Travel Agents wishing to improve knowledge of the Isle of Man Product Offering
- Coach Operators – refreshing itinerary or expand product offering or planning first tour to the Isle of Man
